I CERTIFY THAT ALL OF THIS SCHOOL'S FALL SPORT ATHLETES ARE ELIGIBLE AND THAT ALL FALL SPORT COACHES, ATHLETES, AND THEIR PARENTS/GUARDIANS (AS OF THE DATE INDICATED ABOVE) HAVE SIGNED A COPY OF THE CURRENT "ETHICS IN SPORTS" POLICY. I UNDERSTAND THAT NO FALL SPORT ATHLETE OR COACH WILL BE PERMITTED TO PARTICIPATE REPRESENTING OUR SCHOOL AFTER THE DATE ABOVE UNTIL THEY HAVE SUBMITTED A SIGNED COPY OF THE POLICY. PENALTY FOR FAILURE TO COMPLY WITH THIS REQUIREMENT IS FORFEITURE OF CONTESTS IN WHICH ILLEGAL PARTICIPANTS PARTICIPATED AND EXCLUSION FROM PLAYOFFS IN ACCORDANCE WITH CIFSDS FORFEIT POLICY.

AS A CONDITION OF MEMBERSHIP AND CONTINUING MEMBERSHIP IN THE CIF-SAN DIEGO SECTION, OUR SCHOOL AGREES:

- TO ABIDE BY ALL RULES, REGULATIONS, AND BYLAWS (INCLUDING THE 16 PRINCIPLES OF PURSUING VICTORY WITH HONOR) OF THE STATE CIF AND THE CIF-SAN DIEGO SECTION AS INCORPORATED IN THE STATE CIF CONSTITUTION AND BYLAWS AND THE CIF-SAN DIEGO SECTION GREEN BOOK, AS WELL AS ALL DECISIONS OF THE BOARD OF MANAGERS AND COMMISSIONER, AND REQUIRE PARENTS AND ATHLETES TO ALSO COMPLY.
- TO HAVE EACH COACH, PARENT/GUARDIAN, AND STUDENT-ATHLETE SIGN THE ETHICS IN SPORTS POLICY, TO KEEP IT ON FILE, AND TO SUBMIT THE COMPLIANCE FORM TO THE CIFSDS OFFICE BY THE DUE DATE EACH SEASON OF SPORT. FAILURE TO COMPLY WILL RESULT IN OUR SCHOOL BEING EXCLUDED FROM PLAYOFF CONSIDERATION AND OUR SCHOOL WILL NOT REQUEST AN EXCEPTION TO THIS PROVISION.
- TO HAVE SPORT OFFERINGS GENDER BALANCED; I.E., A BOYS' SPORT AS WELL AS A GIRLS' SPORT MUST BE OFFERED EACH SEASON OF SPORT.
- TO ADVISE PARENTS/GUARDIANS AND STUDENT-ATHLETES OF THE SPORTS OFFERED BY THE SCHOOL AND TO INFORM THEM THAT THE STUDENT-ATHLETE MAY NOT PARTICIPATE AT ANOTHER SCHOOL IN A SPORT NOT OFFERED BY OUR SCHOOL, AND OUR SCHOOL AND STUDENT-ATHLETES ARE NOT AN EXCEPTION TO THIS PROVISION.
- TO COMPLY WITH BYLAW 302 – "MULTI-SCHOOL TEAMS" AND TO ADVISE PARENTS/GUARDIANS THAT ATHLETES MAY NOT PARTICIPATE AT ANOTHER SCHOOL IF THE SCHOOL DOES NOT OFFER A SPORT.
- TO ADVISE PARENTS/GUARDIANS THAT ATHLETES WHO TRANSFER TO THIS SCHOOL, AFTER ESTABLISHING ATHLETIC ELIGIBILITY AT A FORMER SCHOOL, MAY HAVE LIMITED ELIGIBILITY ONLY.
- TO ADVISE PARENTS/GUARDIANS AND TRANSFERRING ATHLETES THAT IF THIS SCHOOL OFFERS ONLY VARSITY-LEVEL PROGRAMS, IT IS NOT CONSIDERED AN EXCEPTION TO THE CIF REQUIREMENT OF LIMITED ELIGIBILITY FOR TRANSFER ATHLETES.
- TO CHARGE PRESCRIBED ADMISSION FEES AT ALL CIFSDS PLAYOFF CONTESTS.
- TO ATTEND CIFSDS TRAINING WORKSHOPS (INCLUDING MANDATORY ATTENDANCE AT CIFSDS SYMPOSIUM) AND TO COMPLY WITH ALL CIF REQUIREMENTS FOR COACHING EDUCATION.
- TO ATTEND ALL CONFERENCE AND LEAGUE MEETINGS.
- TO PROVIDE SAFE, PLAYABLE ATHLETIC FACILITIES APPROPRIATE FOR HIGH SCHOOL COMPETITION THAT ACCOMMODATE PAYING SPECTATORS.
- TO SUPERVISE SPECTATORS AND FANS AT ALL HOME AND AWAY CONTESTS AT THE APPROPRIATE LEVEL AS A SCHOOL SITE RESPONSIBILITY.

I AFFIRM THAT ALL STUDENT-ATHLETES, PARENTS/GUARDIANS, AND COACHES INVOLVED WITH FALL SPORTS HAVE SIGNED THE ETHICS IN SPORTS FORM; THAT ONLY ELIGIBLE STUDENTS WILL BE ALLOWED TO PARTICIPATE; AND THAT THIS SCHOOL SHALL ABIDE BY THE CURRENT RULES OF MEMBERSHIP IN THE CIFSDS-SAN DIEGO SECTION.
